

#### INFORMATION:

#### **Executive Director Discussion:**

- 1. Medicaid Information for March 2024.
- 2. DASH Plans-Internal Evaluators with Every District-Districts were notified in January that an internal DASH reviewer would need to be assigned beginning in the 2024-2025 school year. That candidate would need to be certified in order to begin reviewing next year.
- 3. Stakeholder's meetings (5 quadrants)-During the week of Spring Budget a meeting with Dr. Cage was scheduled in order to discuss SDAA contracts and scope of work amongst the RECs. While traveling to Albuquerque the directors were notified that morning that the OSE cancelled the meeting. The notification was provided in an email. Since that time, we have reached out through email in attempts to reschedule the meeting. We have received information from the OSE regarding the state being divided into 5 quadrants with stake holders meetings planned for each region. Our meeting has been scheduled for May 14, 2024 in Ruidoso which I plan to attend.

- 4. Lovington Membership-In research of the process regarding membership in the REC7 the following has been determined. A proposal was presented to the Lovington School Board on April 9, 2024 to which the board approved the proposal presented by the Executive Director and board of REC7. The Lovington Board will need to approve the minutes at the next board meeting in May. The board of REC7 will approve membership proposal. A membership request will be sent to the Secretary of Education regarding application of Lovington membership consideration. A resolution will be sent supporting the membership in the Regional Education Cooperative VII for Lovington.
- 5. Job Fair Proposal Recruitment-Short power point presentation-A proposal to attend job fairs at universities in surrounding areas is recommended in order to provide a platform for member districts belonging to the REC7 beginning in Spring of 2025. The Executive Director will attend the job fair and provide factual sheets and SWAG regarding participating districts. In addition, personal testimony will be provided as the director has had opportunities of working in the member districts and first-hand knowledge of the people and resources, especially in the area of special education. There is a small fee to have a booth in the job fairs in which the REC7 will pay and split the cost accordingly among the participating districts. This will provide awareness of the districts and opportunities outlined in Southeast New Mexico.
