

CONSIDERATION OF APPROVAL OF SKYWARD STUDENT 3 YEAR SERVICE AGREEMENT Motion by Mr. Loftis for approval of 3-year Service Agreement with Skyward for their student information system for Eunice, Jal and Tatum; motion unanimously carried.

Executive Director Discussion:

- 1. Medicaid Information for February 2024.
- 2. Parent Square Presentation-We are happy to have Amy Serrano here to provide and overview of Parent Square. Amy will send pricing packages to Executive Director via email.
- 3. Academic Competition-State competition was held March 4-5, 2024 in Albuquerque. Teams were represented from Tatum and Hobbs. Tatum won the state championship against Texico and Hobbs took third place. We are very happy for our winners. I received text messages from other directors congratulating Region 7. The students were also complemented on their manners and behavior during the competition.
- 4. Dr. Cage Visit-Meeting with Dr. Cage and directors in order to review mission and vision for the RECs. I have enclosed an agenda from that meeting in your folders. The directors also developed a letter indicating the scope of work within the RECs and the percentage of students impacted by that work. That is also in your packet. Veteran directors discussed the establishment of the RECs and their roles in providing services for member districts. Dr. Cage asked questions regarding the definition of "Member Districts" as well as how all services were designed and structured within the REC. She indicated that she previously sat in on a training and there was some misinformation being provided; therefore, they do not want districts to be confused and do not want districts to think that the information is being provided by the OSE. She requested that calendars of events be shared with the OSE. In addition, it was suggested that a vendor list be developed between the OSE and RECs in order to ensure that both entities have an awareness of the presenters. She requested that the OSE meet with the RECs on a quarterly basis in order to have collaboration. I offered to host a meeting and also have Dr. Cage and staff go to rural districts during the visit. We are scheduled for November. The first meeting will be held in Albuquerque during the week of Spring Budget where we will review SDAA funding. Damon Terry will host a meeting in May and Bryan Dooley will host in August. The OSE asked about the RECs role in literacy and specifically asked questions regarding the grant for ECLIPSE and want a clear definition of what it is, etc. Overall, it was indicated that contracts and scope of work will change.
