

Executive Director Discussion:

- 1. Medicaid Information for August 2023.
- 2. Tech Initiative Update-This is regarding the Technology Grant in which the REC participates in several areas, including Academic Competition. Pat and I visited with the staff at CTECH (Andrew Toglia, Kristi Hughes, Jose Mares). Repair Depot-funding was substantially less than previous year; however, the staff worked out a plan to implement the current budget. They began work in September. Jose Mares is here to provide more information.
- 3. Certified Reviewer DASH-I completed the assessments required for the DASH certification and have started reviewing plans in the smaller districts.
- 4. COGNIA-Representative visited with REC directors regarding live regional sessions in order to provide an assessment literacy overview. It is basically to ensure that all leaders are using consistent language regarding assessment. The session is free to NM educators and targets anyone in leadership roles (superintendents, principals, assistants, academic coaches, instructional directors, etc.). The session would also include a review of tools and resources and ways to develop formative practices in the classroom as well as applying balanced assessment systems will be covered. 7-9 in person opportunities will be provided with 1 webinar-based session for those who cannot attend in person. Gregory Howell is currently working on combining regions for an October 25the date in Portales. See handout in folder.
- 5. Open Forum with Secretary of Education 9/20/23-Superintendents and directors were present for meeting. Questions were asked regarding attendance, transportation, alternative certification, recruitment and retention, school board members training and possible solutions to the issues involved in each.
