

Executive Director Discussion:

- 1. Medicaid Information for September 2023.
- 2. EdTech Boost Update-We have had a great response in the number of people who have registered to participate in the Ed Tech Boost program. Kristy Hughes from C-Tech will be serving as the Data Point of Contact for the program. Because the EdTech Boost has not reached the 300-participant cap within the program, they are allowing districts to surpass the 30 participants, As of October 4, REC 7 has 43 educators registered. Each of the 10 RECs were allocated funding for 30 educators to participate in the EdTech Boost NM Program. However, instead of turning away educators from an REC that reached their 30-participant limit, they opted to allow RECs to recruit as many educators as possible so long as we did not exceed the 300 total for the program. As such, in order to accommodate all the additional registered educators for that REC, we need to move those registrations to an REC that has slots available. By implementing this shift of registrations, they are able to fund the additional educators and ensure that everyone will receive the support and resources they need. Point of Contact for matters related to travel expenses, stipends, and other program related inquiries will be Damon Terry. The REC Director overseeing the program will be Damon Terry. The EdTech Specialist will be Tessa Talsma. While the original REC director may occasionally check in on progress, the aforementioned individuals will be primary contacts for all matters concerning your participation and compensation in the EdTech Boost Program.
- 3. NM SED Director-Margaret Cage, Ed.D, as Special Education Director began work on October 2, 2023 and is from Louisiana. She has certification in Special Education, Masters in Educational Leadership and a Doctorate of Executive Leadership.
- 4. Toolbox 4.3 Update-Met through ZOOM with Elena Gallegos regarding workshop due to high interest level at the previous board meeting. I was able to get quotes regarding cost of booklets, maximum number of attendees and possible dates in January that she is available. The workshop would benefit administration, IEP case managers, related service providers, etc.
